City Manager Larry Collins reported that the ice rink should be started this week, the holdup will be the chiller coming in from Canada. Mr. Collins will be travelling to Washington DC with Council Members Guiley and Street on Wednesday and Thursday to meet with the grant group and federal agencies that provide the grants.

Fire Chief Rod Bordner reported that the department had a busy weekend with running stand-by at the football stadium, 2 structure fires outside the City and 1 in the City. Council Member Guiley reported that the property was close to his and other departments were able to assist and thankfully the property owner was not there but able to get there.

Police Chief Andy Turowski reported that the speed signs are up and will be moved later to locations where needed. It is budgeted for the purchase of the digital keys that maintain the data records.
